



### **Notification of Source of Distributions**

Pursuant to Rule 19a-1 of the Investment Company Act of 1940

As noted below, Diversified Select Real Asset Fund made distributions for the month of March 2021 for which a portion is estimated to be in excess of the fund's current and accumulated net income. As of March 31, 2021, the estimated sources of the distribution were 62.77% from net income and 37.23% from realized gains.

The ultimate composition of these distributions may vary from the estimates provided above due to a variety of factors including future income and expenses, and realized gains and losses from the purchase and sale of securities.
